

PREA ANNUAL REPORT



REPORTING PERIOD

As required by the Prison Rape Elimination Act (PREA), Pub. L. No. 108-79 (2003), GEO has collected and reviewed data on allegations reported from January 1, 2019 through December 31, 2019¹. The GEO Group produced this report in compliance with 28 C.F.R. Part §§115.87-89. This data was collected through the review of the following information:

- Information entered by PREA compliance managers in the GEO PREA database; and,
- Reports/investigations of the GEO Office of Professional Responsibility (OPR).

In 2019, 608 allegations met the definitions of sexual abuse or harassment. This report reflects the status of 2019 allegations as of May 31, 2020. As of that date, 158 of 608 investigations remained on-going from calendar year 2019.

POLICY SUMMARY²

GEO mandates zero tolerance towards all forms of sexual abuse and sexual harassment in all its facilities. It is GEO's policy that sexual conduct between employees, volunteers, or contractors and inmates/detainees/residents, regardless of consensual status, is prohibited and subject to administrative, criminal and disciplinary sanctions. Personal identifiers were omitted from this report to ensure the safety and security of staff and individuals housed in our facilities.

GEO FACILITIES COVERED THIS REPORT (99 FACILITIES)

This report contains PREA data collected from all GEO facilities covered by DOJ PREA Standards. It does not contain PREA data collected from GEO facilities housing Immigration Customs Enforcement (ICE) detainees, as these facilities fall under the Department of Homeland Security (DHS) PREA Standards and data from these facilities will be reported as required by DHS. This report includes a comparison of 2018 and 2019 data as required by PREA Standard §115.88 - Data review for corrective action.

The following 99 facilities are covered in this Report:

- 47 corrections and detention facilities
- 3 iail facilities
- 41 residential reentry centers
- 8 youth services facilities

GENERAL DEFINITIONS⁴

- Contractor: a person who provides services on a recurring basis pursuant to a contractual agreement with the agency.
- Detainee: any person detained in a lockup, regardless of adjudication status.
- Employee: a person who works directly for the agency or facility.
- Inmate: any person incarcerated or detained in a prison or jail.
- On-going (OG): investigation has not been completed.
- Resident: any person confined or detained in a juvenile facility or in a community confinement facility.
- Staff:5 employees.
- Substantiated (SUB): an allegation that was investigated and determined to have occurred.
- Unfounded (UF): an allegation that was investigated and determined not to have occurred.
- Unsubstantiated (UNSUB): an allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.
- Volunteer: an individual who donates time and effort on a recurring basis to enhance the activities and programs of the agency.

DEFINITIONS RELATED TO SEXUAL ABUSE & HARASSMENT⁶

- Sexual Abuse
- (1) Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident; and
- (2) Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer.

Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident includes any of the following acts, if the victim does not consent, is coerced into such act by overt or implied threats of violence, or is unable to consent or refuse:

- (1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;
- (2) Contact between the mouth and the penis, vulva, or anus;
- (3) Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object, or other instrument; and
- (4) Any other intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or the buttocks of another person, excluding contact incidental to a physical altercation.



Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer includes any of the following acts, with or without consent of the inmate, detainee, or resident:

- (1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;
- (2) Contact between the mouth and the penis, vulva, or anus;
- (3) Contact between the mouth and any body part where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (4) Penetration of the anal or genital opening, however slight, by a hand, finger, object, or other instrument, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (5) Any other intentional contact, either directly or through the clothing, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (6) Any attempt, threat, or request by a staff member, contractor, or volunteer to engage in the activities described in paragraphs (1)-(5) of this section;
- (7) Any display by a staff member, contractor, or volunteer of his or her uncovered genitalia, buttocks, or breast in the presence of an inmate, detainee, or resident, and
- (8) Voyeurism by a staff member, contractor, or volunteer.

Voyeurism by a staff member, contractor, or volunteer means an invasion of privacy of an inmate, detainee, or resident by staff for reasons unrelated to official duties, such as peering at an inmate who is using a toilet in his or her cell to perform bodily functions; requiring an inmate to expose his or her buttocks, genitals, or breasts; or taking images of all or part of an inmate's naked body or of an inmate performing bodily functions.

- Sexual Harassment
- (1) Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate, detainee, or resident directed toward another; and
- (2) Repeated verbal comments or gestures of a sexual nature to an inmate, detainee, or resident by a staff member, contractor, or volunteer, including demeaning references to gender, sexually suggestive or derogatory comments about body or clothing, or obscene language or gestures.

EVIDENTIARY STANDARD

The agency shall impose no standard higher than a preponderance of the evidence in determining whether allegations of sexual abuse or sexual harassment are substantiated.⁷

In 2019, there were 608 allegations in the four incident types listed above. Every allegation was referred for investigation and 40 (27 sexual abuse and 13 sexual harassment) were substantiated after investigation. All cases involving staff are received, assessed and processed by the GEO Office of Professional Responsibility. If any allegation is a crime, GEO will refer the allegation of sexual abuse or sexual harassment for investigation to an agency with the legal authority to conduct criminal investigations.

Furthermore, of the 155 allegations involving staff and sexual abuse received in 2019, 41 were pat search allegations; all were investigated, and none were substantiated. The majority were determined unfounded, as the touching was incidental to staff performing official duties in accordance with established search policies or after review of facility video monitoring technology.

- GEO received 608 allegations in 2019. Allegations decreased from 618 in 2018 by -10 to 608 in 2019.
- U.S. Secure Services received 399 allegations in 2019. Allegations decreased from 434 in 2018 by -35 to 399 in 2019.
- Reentry Services received 113 allegations in 2019. Allegations increased from 110 in 2018 by 3 to 113 in 2019.
- Youth Services received 96 allegations in 2019. Allegations increased from 74 in 2018 by 22 to 96 in 2019.

- There were 40 substantiated allegations GEO-wide in 2019. Substantiated allegations decreased from 41 in 2018 by -1 to 40 in 2019.
- There were 24 substantiated allegations for U.S. Secure Services in 2019. Substantiated allegations decreased from 26 in 2018 by 2 to 24 in 2019.
- There were 9 substantiated allegations for Reentry Services in 2019. Substantiated allegations increased from 7 in 2018 by 2 to 9 in 2019.
- There were 7 substantiated allegations for Youth Services in 2019. Substantiated allegations decreased from 8 in 2018 by -1 to 7 in 2019.

- There were 246 IISA/RRSA allegations reported to GEO in 2019. IISA/RRSA allegations increased from 221 in 2018 by 25 to 246 in 2019.
- There were 158 IISA allegations reported to U.S. Secure Services in 2019. IISA allegations decreased from 168 in 2018 by -10 to 158 in 2019.
- There were 24 IISA allegations reported to Reentry Services in 2019. IISA allegations increased from 17 in 2018 by 7 to 24 in 2019.
- There were 64 RRSA allegations reported to Youth Services in 2019. RRSA allegations increased from 36 in 2018 by 28 to 64 in 2019.

- There were 111 IISH/RRSH allegations reported to GEO in 2019. IISH/RRSH allegations decreased from 117 in 2018 by -6 to 111 in 2019.
- There were 77 IISA allegations reported to U.S. Secure Services in 2019. IISH allegations decreased from 83 in 2018 by -6 to 77 in 2019.
- There were 23 IISH allegations reported to Reentry Services in 2019. IISH allegations decreased from 24 in 2018 by -1 to 23 in 2019.

- There were 165 SISA/SRSA allegations reported to GEO in 2019. SISA/SRSA allegations decreased from 181 in 2018 by -16 to 165 in 2019.
- There were 106 SISA allegations reported to U.S. Secure Services in 2019. SISA allegations decreased from 116 in 2018 by -10 to 106 in 2019.
- There were 46 SISA allegations reported to Reentry Services in 2019. SISA allegations increased from 45 in 2018 by 1 to 46 in 2019.

- There were 86 SISH/SRSH allegations reported to GEO in 2019. SISH/SRSH allegations decreased from 99 in 2018 by -13 to 86 in 2019.
- There were 58 SISH allegations reported to U.S. Secure Services in 2019. SISH allegations decreased from 67 in 2018 by -7 to 60 in 2019.
- There were 20 SISH allegations reported to Reentry Services in 2019. SISH allegations decreased from 24 in 2018 by -4 to 20 in 2019.
- There were 8 SRSH allegations reported to Youth Services in 2019; there was no change in the number of SRSH allegations reported.

2019 PROGRAM ENHANCEMENTS

Actions in 2019:

In 2019, GEO implemented the following actions to enhance the prevention and detection of any incidents and to enhance responses to allegations of sexual abuse and sexual harassment:

Corporate Enhancements

- All GEO PREA policies were reviewed and updated to incorporate procedures for enhanced tracking
 of potential victims and abusers following reported allegations in all facilities, protocols for
 offering follow-up mental health services to residents in community confinement facilities, guidelines
 for conducting unannounced rounds and time frames for medical and mental health employees to
 complete required specialized training.
- The Contract Compliance Department, in consultation with the Office of Professional Responsibility, implemented an investigation "short form template" for inmate and staff allegations to decrease the amount of time to finalize an investigation report and to maintain consistency between departments.
- The Contract Compliance Department assigned a corporate PREA manager that serves as a single point of contact for each facility. The PREA manager will facilitate investigations, audits, and PREA compliance for facilities under GEO's operational control.
- A third-party PREA reporting hotline and email address were added to the third-party reporting signs: the hotline and email route to the corporate PREA contract compliance team. A third-party reporter is someone who reports sexual abuse and harassment but is neither the victim nor abuser. The third-party reporting signs were standardized GEO-wide.

• Training and education of employees, contractors and volunteers

- One corporate PREA manager attended DOJ PREA Auditor Refresher Training in January and August 2019.
- User training on reporting and navigation in the PREA database was provided to all newly assigned PREA compliance managers in U.S. Secure Services, Residential Reentry and Youth Services.
- Employees, contractors and volunteers received annual PREA in-service training in accordance with established GEO PREA policies in 2019.
- 68 employees from U.S. Secure Services, Residential Reentry and Youth Services received PREA Specialized Investigations Training facilitated by the corporate PREA coordinator to enhance skills in dealing with victims of sexual abuse.
- Training continued for new hires and in-service.

Assessment of Physical Plant Issues at Facilities

• Annual PREA Facility Assessments were conducted in all GEO U.S. Secure Services, Residential Reentry, and Youth Service facilities to identify areas needing improvement to enhance the company's ability to protect inmates, detainees, and residents from sexual abuse and sexual harassment. All recommendations for enhancements were submitted and reviewed by the corporate PREA coordinator and appropriate divisional authority. To enhance supervision of facility blind spots, 8 facilities added additional video monitoring cameras, 18 facilities recommended adding/updating camera surveillance monitoring systems, 7 facilities added dome security mirrors, and 3 facilities recommended adding dome mirrors. In addition, 1 facility added signs on doors in areas where no residents are allowed, 1 facility recommended additional PREA investigators, and 1 facility recommended dimmed nighttime lighting.
