

PREA ANNUAL REPORT 2020



REPORTING PERIOD

As required by the Prison Rape Elimination Act (PREA), Pub. L. No. 108-79 (2003), GEO has collected and reviewed data on allegations reported from January 1, 2020 through December 31, 2020¹. The GEO Group produced this report in compliance with 28 C.F.R. Part §§115.87-89. This data was collected through the review of the following information:

- Information entered by PREA compliance managers in the GEO PREA database; and,
- Reports/investigations of the GEO Office of Professional Responsibility (OPR).

In 2020, 447 allegations met the definitions of sexual abuse or harassment. This report reflects the status of 2020 allegations as of May 31, 2021. As of that date, 68 of 447 investigations remained on-going from calendar year 2020.

POLICY SUMMARY²

GEO mandates zero tolerance towards all forms of sexual abuse and sexual harassment in all its facilities. It is GEO's policy that sexual conduct between employees, volunteers, or contractors and inmates/detainees/residents, regardless of consensual status, is prohibited and subject to administrative, criminal and disciplinary sanctions. Personal identifiers were omitted from this report to ensure the safety and security of staff and individuals housed in our facilities.

KEY OPERATIONAL CHANGES

GEO FACILITIES COVERED THIS REPORT (95 FACILITIES)

This report contains PREA data collected from all GEO facilities covered by DOJ PREA Standards. It does not contain PREA data collected from GEO facilities housing Immigration Customs Enforcement (ICE) detainees, as these facilities fall under the Department of Homeland Security (DHS) PREA Standards and data from these facilities will be reported as required by DHS. This report includes a comparison of 2019 and 2020 data as required by PREA Standard §115.88 - Data review for corrective action.

The following 95 facilities are covered in this Report:

- 48 corrections and detention facilities
- 39 residential reentry centers
- 8 youth services facilities

GENERAL DEFINITIONS⁴

- **Contractor**: a person who provides services on a recurring basis pursuant to a contractual agreement with the agency.
- **Detainee**: any person detained in a lockup, regardless of adjudication status.
- Employee: a person who works directly for the agency or facility.
- Inmate: any person incarcerated or detained in a prison or jail.
- On-going (OG): investigation has not been completed.
- Resident: any person confined or detained in a juvenile facility or in a community confinement facility.
- Staff:5 employees.
- Substantiated (SUB): an allegation that was investigated and determined to have occurred.
- Unfounded (UF): an allegation that was investigated and determined not to have occurred.
- **Unsubstantiated (UNSUB)**: an allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.
- **Volunteer**: an individual who donates time and effort on a recurring basis to enhance the activities and programs of the agency.

DEFINITIONS RELATED TO SEXUAL ABUSE & HARASSMENT⁶

Sexual Abuse

- (1) Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident; and
- (2) Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer.

Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident includes any of the following acts, if the victim does not consent, is coerced into such act by overt or implied threats of violence, or is unable to consent or refuse:

- (1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;
- (2) Contact between the mouth and the penis, vulva, or anus;
- (3) Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object, or other instrument; and
- (4) Any other intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or the buttocks of another person, excluding contact incidental to a physical altercation.

Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer includes any of the following acts, with or without consent of the inmate, detainee, or resident:

- (1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;
- (2) Contact between the mouth and the penis, vulva, or anus;
- (3) Contact between the mouth and any body part where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (4) Penetration of the anal or genital opening, however slight, by a hand, finger, object, or other instrument, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (5) Any other intentional contact, either directly or through the clothing, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (6) Any attempt, threat, or request by a staff member, contractor, or volunteer to engage in the activities described in paragraphs (1)-(5) of this section;
- (7) Any display by a staff member, contractor, or volunteer of his or her uncovered genitalia, buttocks, or breast in the presence of an inmate, detainee, or resident, and
- (8) Voyeurism by a staff member, contractor, or volunteer.

Voyeurism by a staff member, contractor, or volunteer means an invasion of privacy of an inmate, detainee, or resident by staff for reasons unrelated to official duties, such as peering at an inmate who is using a toilet in his or her cell to perform bodily functions; requiring an inmate to expose his or her buttocks, genitals, or breasts; or taking images of all or part of an inmate's naked body or of an inmate performing bodily functions.

Sexual Harassment

- (1) Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate, detainee, or resident directed toward another; and
- (2) Repeated verbal comments or gestures of a sexual nature to an inmate, detainee, or resident by a staff member, contractor, or volunteer, including demeaning references to gender, sexually suggestive or derogatory comments about body or clothing, or obscene language or gestures.

EVIDENTIARY STANDARD

The agency shall impose no standard higher than a preponderance of the evidence in determining whether allegations of sexual abuse or sexual harassment are substantiated.⁷

In 2020, there were 447 allegations in the four incident types listed above. Every allegation was referred for investigation and 47 (25 sexual abuse and 22 sexual harassment) were substantiated after investigation. All cases involving staff are received, assessed, and processed by the GEO Office of Professional Responsibility. If any allegation is a crime, GEO will refer the allegation of sexual abuse or sexual harassment for investigation to an agency with the legal authority to conduct criminal investigations.

Furthermore, of the 122 allegations involving staff and sexual abuse received in 2020, 27 were pat search allegations; all were investigated, and none were substantiated. The majority were determined unfounded, as the touching was incidental to staff performing official duties in accordance with established search policies or after review of facility video monitoring technology.

- GEO received 447 allegations in 2020. Allegations decreased from 608 in 2019 to 447 in 2020. This is a decrease of 161 allegations..
- U.S. Secure Services received 322 allegations in 2020. Allegations decreased from 399 in 2019 by to 322 in 2020. This is a decrease of 77 allegations.
- GEO Care's Reentry Services received 80 allegations in 2020. Allegations decreased from 113 in 2019 to 80 in 2020. This is a decrease of 33 allegations.
- Abraxas Youth Services received 45 allegations in 2020. Allegations decreased from 96 in 2019 45 in 2020. This is a decrease of 51 allegations.

- There were 47 substantiated allegations GEO-wide in 2020. Substantiated allegations increased from 40 in 2019 to 47 in 2020. This is an increase of 7 substantiated allegations.
- There were 30 substantiated allegations for U.S. Secure Services in 2020. Substantiated allegations increased from 24 in 2019 to 30 in 2020. This is an increase of 6 substantiated allegations.
- There were 14 substantiated allegations for Reentry Services in 2020. Substantiated allegations increased from 9 in 2019 to 14 in 2020. This is an increase of 5 substantiated allegations.
- There were 4 substantiated allegations for Youth Services in 2020. Substantiated allegations decreased from 7 in 2019 to 3 in 2020. This is a decrease of 4 substantiated allegations.

- There were 165 IISA/RRSA allegations reported to GEO in 2020. IISA/RRSA allegations decreased from 246 in 2019 to 165 in 2020. This is a decrease of 81 IISA/RRSA allegations.
- There were 126 IISA allegations reported to U.S. Secure Services in 2020. IISA allegations decreased from 158 in 2019 to 126 in 2020. This is a decrease of 32 IISA allegations.
- There were 17 IISA allegations reported to Reentry Services in 2019. IISA allegations decreased from 24 in 2019 to 17 in 2020. This is a decrease of 7 IISA allegations.
- There were 22 RRSA allegations reported to Youth Services in 2020. RRSA allegations decreased from 64 in 2019 by 22 in 2020. This is a decrease of 42 RRSA allegations.

- There were 81 IISH/RRSH allegations reported to GEO in 2020. IISH/RRSH allegations decreased from 111 in 2019 to 81 in 2020. This is a decrease of 30 IISH/RRSH allegations.
- There were 62 IISA allegations reported to U.S. Secure Services in 2020. IISH allegations decreased from 77 in 2019 to 62 in 2020. This is a decrease of 15 IISH allegations.
- There were 14 IISH allegations reported to Reentry Services in 2020. IISH allegations decreased from 23 in 2019 to 14 in 2020. This is a decrease of 9 IISH allegations.

- There were 122 SISA/SRSA allegations reported to GEO in 2020. SISA/SRSA allegations decreased from 165 in 2019 to 122 in 2020. This is a decrease of 43 SISA/SRSA allegations.
- There were 72 SISA allegations reported to U.S. Secure Services in 2020. SISA allegations decreased from 106 in 2019 to 72 in 2020. This is a decrease of 34 SISA allegations.
- There were 39 SISA allegations reported to Reentry Services in 2020. SISA allegations decreased from 46 in 2019 to 39 in 2020. This is a decrease of 7 SISA allegations.
- There were 11 SRSA allegations reported to Youth Services in 2020. SRSA allegations decreased from 13 in 2019 to 11 in 2020. This is a decrease of 2 SRSA allegations.

- There were 79 SISH/SRSH allegations reported to GEO in 2020. SISH/SRSH allegations decreased from 86 2019 to 79 in 2020. This is a decrease of 7 SISH/SRSH allegations.
- There were 62 SISH allegations reported to U.S. Secure Services in 2020. SISH allegations increased from 58 in 2019 to 62 in 2020. This is an increase of 4 SISH allegation.
- There were 10 SISH allegations reported to Reentry Services in 2020. SISH allegations decreased from 20 in 2019 to 10 in 2020. This is a decrease of 10 SISH allegations.
- There were 7 SRSH allegations reported to Youth Services in 2020. SRSH allegations decreased from 8 in 2019 to 7 in 2020. This is a decrease of 1 SRSH allegation.

2020 PROGRAM FNHANCEMENTS

Actions in 2020:

In 2020, GEO implemented the following actions to enhance the prevention and detection of any incidents and to enhance responses to allegations of sexual abuse and sexual harassment:

• Corporate Enhancements

- All GEO's PREA policies were reviewed, and the zero-tolerance policy and PREA investigations procedure were updated. The zero-tolerance policy was revised to standardize terminology used by GEO with the PREA standards. The PREA investigations procedure was updated to clearly delineate GEO staff and law enforcement entities' responsibilities following PREA allegations.
- A revised procedure for tracking investigations was implemented at the corporate, regional, and facility levels. PCMs, regional directors, and the corporate PREA team receive monthly reports of open PREA investigations. This increased oversight facilitated the timely closure of investigations.

• Training and education of employees, contractors and volunteers

- PCMs were provided with a PCM Orientation Guide to support them in carrying out their duties implementing the PREA standards. The guide complements GEO's PREA policy, the PREA standards, and provides PCM's a basis for understanding how GEO incorporates the PREA standards into its written policies.
- A Specialized PREA Investigation Training course was developed and incorporated into GEO's learning management system. Each PREA investigator candidate must complete a practical writing exercise where a corporate PREA manager reviews an IISA/RRSA and an SRSA/SRSA investigative report before receiving an investigator's certification.
- A Specialized Medical and Mental Health PREA Training course was developed and incorporated into GEO's learning management system.

The course focuses on:

- Detecting and assessing signs of sexual abuse and sexual harassment;
- Identifying and preserving physical evidence of sexual abuse;
- Respond effectively and professionally to victims of sexual abuse and sexual harassment; and
- Reporting allegations or suspicions of sexual abuse and sexual harassment.
- The corporate PREA team attended the American Correctional Association Conference in San Diego, CA. One team member attended DOJ PREA Auditor Refresher Training and the rest participated in PREA workshops.
- PREA database user training was provided to all newly assigned PCMs in U.S. Secure Services, Residential Reentry, and Youth Services.
- Employees, contractors, and volunteers received annual PREA in-service training as required by GEO PREA policies in 2020.

Assessment of Physical Plant Issues at Facilities

Annual PREA Facility Assessments were conducted in all GEO U.S. Secure Services, Residential Reentry, and Youth Service facilities to identify areas needing improvement to enhance the company's ability to protect inmates, detainees, and residents from sexual abuse and sexual harassment. All recommendations for enhancements were submitted and reviewed by the corporate PREA coordinator and appropriate divisional authority. For example, to reduce blind spots, 28 facilities recommended adding or updating camera surveillance monitoring systems, 12 facilities added additional video monitoring cameras, 7 facilities added dome security mirrors, and 3 facilities recommended adding dome mirrors. Additional recommendations were made to add signs on doors in areas where no residents are allowed, install curtains and partitions for privacy, enhance the PREA education program with additional languages, add PREA investigators, improve the lighting, hire new staff to identify and monitor at risk-inmates, create pocket cards with important telephone numbers and facility codes for staff, develop and implement an internal perpetual audit system to self-identify any areas of weakness, install a Morse Key Watcher system, and install new door locks and remove interior locks.
