## 2022 PREA Annual Report

#### **REPORTING PERIOD**

As required by the Prison Rape Elimination Act (PREA), Pub. L. No. 108-79 (2003), The GEO Group, Inc. (GEO) has collected and reviewed its data on allegations reported from January 1, 2022, through December 31, 2022.<sup>1</sup> GEO produced this report by following the requirements in 28 C.F.R. § 115.87-89. This data was collected through the review of the following information:

- Information entered by PREA compliance managers in GEO's PREA database; and,
- Reports from GEO's Office of Professional Responsibility (OPR).

In 2022, there were a total of 417 allegations that met the definitions of sexual abuse or harassment. This report reflects the status of those allegations as of June 9, 2023. As of that date, 38 of the 417 allegations that met the definitions of sexual abuse or harassment remained under active investigation, all by outside law enforcement agencies.

#### **POLICY SUMMARY<sup>2</sup>**

GEO mandates zero tolerance towards all forms of sexual abuse and sexual harassment in all its facilities. It is GEO's policy that sexual conduct between employees, volunteers, or contractors and inmates/detainees/residents, regardless of consensual status, is prohibited and subject to administrative, criminal, and disciplinary sanctions. Personal identifiers were omitted from this report to ensure the safety and security of staff and individuals housed in our facilities.

#### **GEO FACILITIES COVERED IN THIS REPORT (65 FACILITIES)**

This report contains PREA data collected from all GEO Facilities covered by DOJ PREA Standards. It does not contain PREA data collected from GEO facilities housing Immigration Customs Enforcement (ICE) detainees, as these facilities fall under the Department of Homeland Security (DHS) PREA Standards and data from these facilities will be reported as required by DHS. This report includes a comparison of 2021 and 2022 data as required by PREA Standard §115.88 - Data review for corrective action.

The following 65 facilities are covered in this report:

- 29 secure services facilities
- 36 residential reentry centers

#### **GENERAL DEFINITIONS<sup>5</sup>**

- **Contractor**: a person who provides services on a recurring basis pursuant to a contractual agreement with the agency.
- Detainee: any person detained in a lockup, regardless of adjudication status.
- Employee: a person who works directly for the agency or facility.
- Inmate: any person incarcerated or detained in a prison or jail.
- On-going (OG): investigation has not been completed.
- **Resident**: any person confined or detained in a juvenile facility or in a community confinement facility.
- Staff: employees<sup>6</sup>.
- Substantiated (SUB): an allegation that was investigated and determined to have occurred.
- Unfounded (UF): an allegation that was investigated and determined not to have occurred.
- Unsubstantiated (UNSUB): an allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.
- Volunteer: an individual who donates time and effort on a recurring basis to enhance the activities and programs of the agency.

#### **DEFINITIONS RELATED TO SEXUAL ABUSE & HARASSMENT<sup>7</sup>**

#### • Sexual Abuse

(1) Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident; and

(2) Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer.

Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident includes any of the following acts, if the victim does not consent, is coerced into such act by overt or implied threats of violence, or is unable to consent or refuse:

(1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;

(2) Contact between the mouth and the penis, vulva, or anus;

(3) Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object, or other instrument; and



(4) Any other intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or the buttocks of another person, excluding contact incidental to a physical altercation.

Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer includes any of the following acts, with or without consent of the inmate, detainee, or resident:

(1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;

(2) Contact between the mouth and the penis, vulva, or anus;

(3) Contact between the mouth and any body part where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(4) Penetration of the anal or genital opening, however slight, by a hand, finger, object, or other instrument, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(5) Any other intentional contact, either directly or through the clothing, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(6) Any attempt, threat, or request by a staff member, contractor, or volunteer to engage in the activities described in paragraphs (1)-(5) of this section;

(7) Any display by a staff member, contractor, or volunteer of his or her uncovered genitalia, buttocks, or breast in the presence of an inmate, detainee, or resident, and

(8) Voyeurism by a staff member, contractor, or volunteer.

Voyeurism by a staff member, contractor, or volunteer means an invasion of privacy of an inmate, detainee, or resident by staff for reasons unrelated to official duties, such as peering at an inmate who is using a toilet in his or her cell to perform bodily functions; requiring an inmate to expose his or her buttocks, genitals, or breasts; or taking images of all or part of an inmate's naked body or of an inmate performing bodily functions.

#### Sexual Harassment

(1) Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate, detainee, or resident directed toward another; and

(2) Repeated verbal comments or gestures of a sexual nature to an inmate, detainee, or resident by a staff member, contractor, or volunteer, including demeaning references to gender, sexually suggestive or derogatory comments about body or clothing, or obscene language or gestures.



#### **INCIDENT TYPE ACRONYMS**

The following acronyms are used by GEO to track reported allegations of sexual abuse and harassment:

- IISA Inmate-on-Inmate or Detainee-on-Detainee Sexual Abuse

#### **EVIDENTIARY STANDARD**

The agency shall impose no standard higher than a preponderance of the evidence in determining whether allegations of sexual abuse or sexual harassment are substantiated.<sup>8</sup>

In 2022, there were 417 allegations within the four incident types listed above. Every allegation was referred for investigation. A total of 33 allegations, 15 sexual abuse and 18 sexual harassment, were substantiated. All cases involving a staff member were received, investigated, and processed by GEO's Office of Professional Responsibility. If a crime was alleged, GEO referred the allegations of sexual abuse or sexual harassment to an agency with the legal authority to conduct criminal investigations.

- GEO received 417 allegations in 2022. Allegations increased from 404 in 2021 to 417 in 2022. This is an increase of 13 allegations.
- U.S. Secure Services received 357 allegations in 2022. Allegations decreased from 359 in 2021 to 357 in 2022. This is a decrease of 2 allegations.
- Reentry Services received 60 allegations in 2022. Allegations increased from 45 in 2021 to 60 in 2022. This is an increase of 15 allegations.

- There were 33 substantiated allegations GEO-wide in 2022. Substantiated allegations increased from 29 in 2021 to 33 in 2022. This is an increase of 4 substantiated allegations.
- There were 23 substantiated allegations for U.S. Secure Services in 2022. Substantiated allegations remained the same in 2021 and 2022 at 23.
- There were 10 substantiated allegations for Reentry Services in 2022. Substantiated allegations increased from 6 in 2021 to 10 in 2022. This is an increase of 4 substantiated allegations.

- There were 138 IISA allegations reported to GEO in 2022. IISA allegations decreased from 155 in 2021 to 138 in 2022. This is a decrease of 17 IISA allegations.
- There were 124 IISA allegations reported to U.S. Secure Services in 2022. IISA allegations decreased from 144 in 2021 to 124 in 2022. This is a decrease of 20 allegations.
- There were 14 IISA allegations reported to Reentry Services in 2022. IISA allegations increased from 11 in 2021 to 14 in 2022. This is an increase of 3 IISA allegations.

- There were 90 IISH allegations reported to GEO in 2022. IISH allegations increased from 68 in 2021 to 90 in 2022. This is an increase of 22 IISH allegations.
- There were 78 IISA allegations reported to U.S. Secure Services in 2022. IISH allegations increased from 60 in 2021 to 78 in 2022. This is an increase of 18 IISH allegations.
- There were 12 IISH allegations reported to Reentry Services in 2022. IISH allegations increased from 8 in 2021 to 12 in 2022. This is an increase of 4 IISH allegations.

- There were 105 SISA allegations reported to GEO in 2022. SISA allegations increased from 99 in 2021 to 105 in 2022. This is an increase of 6 SISA allegations.<sup>9</sup>
- There were 81 SISA allegations reported to U.S. Secure Services in 2022. SISA allegations remained the same at 81 in 2021 and 81 in 2022.
- There were 24 SISA allegations reported to Reentry Services in 2022. SISA allegations increased from 18 in 2021 to 24 in 2022. This is an increase of 6 SISA allegations.

- There were 84 SISH allegations reported to GEO in 2022. SISH allegations increased from 82 in 2021 by 2 to 84 in 2022. This is an increase of 2 SISH allegations.
- There were 74 SISH allegations reported to U.S. Secure Services in 2022. SISH allegations remained the same in 2021 and 2022 at 74.
- There were 10 SISH allegations reported to Reentry Services in 2022. SISH allegations increased from 8 in 2021 to 10 in 2022. This is an increase of 2 SISH allegations.

#### **2022 PROGRAM ENHANCEMENTS**

#### Actions in 2022:

In 2022, GEO implemented the following actions to enhance the prevention and detection of any incidents and to enhance responses to allegations of sexual abuse and sexual harassment:

#### • Program Enhancements

 The new ClearSight PREA portal was launched in November of 2022. The portal is designed with secure access and ample, secure data storage. A team of subject-matter experts provided PREA portal training for Facility Administrators, Facility Directors, PREA Managers, and PREA Compliance Administrators.



- Training and education of employees, contractors and volunteers
  - Employees, contractors, and volunteers received annual PREA in-service training as required by GEO policies in 2022.
  - Fourteen U.S. Secure Services and Reentry Services employees received PREA Specialized Investigations Training in 2022.

#### • Assessment of Physical Plant Issues at Facilities

- Annual PREA Facility Assessments were conducted in all GEO U.S. Secure Services and Residential Reentry facilities to identify areas needing improvement to enhance the company's ability to protect inmates and detainees from sexual abuse and sexual harassment. All recommendations for enhancements were submitted and reviewed by the corporate PREA coordinator and appropriate divisional authority. For example, to reduce blind spots and enhance surveillance monitoring:
  - Fourteen facilities recommended adding or updating camera surveillance monitoring systems,
  - · Five facilities added additional video monitoring cameras,
  - Five facilities added dome mirrors,
  - Three facilities enhanced their specialized employee PREA training curricula,
  - One facility incorporated a line of PREA related questioning for staff and inmates during their unannounced rounds to foster a positive PREA culture,
  - One facility added translucent coverings to window cutouts between units to eliminate the visibility of inmates from separate units,
  - · One facility installed barriers between each dormitory toilet,
  - One facility programmed tollfree phone numbers into pay phones to allow inmates the ability to dial toll free to report PREA allegations anonymously,
  - One facility fabricated and installed visual blocks on the urinals on the outdoor recreation yards and windows to all inmate restroom doors in program and work areas, and
  - One facility updated its PREA memorandum of understanding with local law enforcement.
