

PREA ANNUAL REPORT 2021



REPORTING PERIOD

As required by the Prison Rape Elimination Act (PREA), Pub. L. No. 108-79 (2003), The GEO Group, Inc. (GEO) has collected and reviewed data on allegations reported from January 1, 2021, through December 31, 2021. GEO produced this report in compliance with 28 C.F.R. § 115.87-89. This data was collected through the review of the following information:

- Information entered by PREA compliance managers in GEO's PREA database; and,
- Reports/investigations from GEO's Office of Professional Responsibility (OPR).

In 2021, there were a total of 429 allegations that met the definitions of sexual abuse or harassment. This report reflects the status of 2021 allegations as of June 6, 2022. The reporting period for Youth Services is (YS) from January 1, 2021, to June 30, 2021, as YS left GEO and became the Abraxas Alliance, Inc. on July 1, 2021. As of June 6, 2022, 41 of 429 investigations remained on-going from the calendar year 2021. Of the 41 on-going investigations, 36 are being conducted by outside law enforcement agencies, and the other 5 are with Abraxas Alliance, Inc.

POLICY SUMMARY²

GEO mandates zero tolerance towards all forms of sexual abuse and sexual harassment in all its facilities. It is GEO's policy that sexual conduct between employees, volunteers, or contractors and inmates/detainees/residents, regardless of consensual status, is prohibited and subject to administrative, criminal, and disciplinary sanctions. Personal identifiers were omitted from this report to ensure the safety and security of staff and individuals housed in our facilities.

GEO FACILITIES COVERED THIS REPORT (79 FACILITIES)

This report contains PREA data collected from all GEO Facilities covered by DOJ PREA Standards. It does not contain PREA data collected from GEO facilities housing U.S. Immigration Customs Enforcement (ICE) detainees, as these facilities fall under the Department of Homeland Security (DHS) PREA Standards and data from these facilities will be reported by DHS. Also, this report will only contain data for Youth Services from January 1, 2021, through June 30, 2021, as the Youth Services division of GEO was transferred to Abraxas Alliance, Inc. on July 1, 2021. This report includes a comparison of 2020 and 2021 data as required by PREA Standard §115.88 - Data review for corrective action.

The following 79 facilities are covered in this Report:

- 37 secure services facilities
- 35 residential reentry centers
- 7 youth services facilities

GENERAL DEFINITIONS⁴

- **Contractor**: a person who provides services on a recurring basis pursuant to a contractual agreement with the agency.
- Detainee: any person detained in a lockup, regardless of adjudication status.
- Employee: a person who works directly for the agency or facility.
- Inmate: any person incarcerated or detained in a prison or jail.
- **On-going (OG)**: investigation has not been completed.
- Resident: any person confined or detained in a juvenile facility or in a community confinement facility.
- Staff:⁵ employees.
- Substantiated (SUB): an allegation that was investigated and determined to have occurred.
- Unfounded (UF): an allegation that was investigated and determined not to have occurred.
- **Unsubstantiated (UNSUB)**: an allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.
- **Volunteer**: an individual who donates time and effort on a recurring basis to enhance the activities and programs of the agency.

DEFINITIONS RELATED TO SEXUAL ABUSE & HARASSMENT⁶

Sexual Abuse

(1) Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident; and

(2) Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer.

Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident includes any of the following acts, if the victim does not consent, is coerced into such act by overt or implied threats of violence, or is unable to consent or refuse:

(1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;

(2) Contact between the mouth and the penis, vulva, or anus;

(3) Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object, or other instrument; and

(4) Any other intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or the buttocks of another person, excluding contact incidental to a physical altercation.

Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer includes any of the following acts, with or without consent of the inmate, detainee, or resident:

(1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;

(2) Contact between the mouth and the penis, vulva, or anus;

(3) Contact between the mouth and any body part where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(4) Penetration of the anal or genital opening, however slight, by a hand, finger, object, or other instrument, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(5) Any other intentional contact, either directly or through the clothing, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(6) Any attempt, threat, or request by a staff member, contractor, or volunteer to engage in the activities described in paragraphs (1)-(5) of this section;

(7) Any display by a staff member, contractor, or volunteer of his or her uncovered genitalia, buttocks, or breast in the presence of an inmate, detainee, or resident, and

(8) Voyeurism by a staff member, contractor, or volunteer.

Voyeurism by a staff member, contractor, or volunteer means an invasion of privacy of an inmate, detainee, or resident by staff for reasons unrelated to official duties, such as peering at an inmate who is using a toilet in his or her cell to perform bodily functions; requiring an inmate to expose his or her buttocks, genitals, or breasts; or taking images of all or part of an inmate's naked body or of an inmate performing bodily functions.

• Sexual Harassment

(1) Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate, detainee, or resident directed toward another; and

(2) Repeated verbal comments or gestures of a sexual nature to an inmate, detainee, or resident by a staff member, contractor, or volunteer, including demeaning references to gender, sexually suggestive or derogatory comments about body or clothing, or obscene language or gestures.

EVIDENTIARY STANDARD

The agency shall impose no standard higher than a preponderance of the evidence in determining whether allegations of sexual abuse or sexual harassment are substantiated.⁷

In 2021, there were 429 allegations in the four incident types listed above. Every allegation was referred for investigation and a total of 31 allegations, 15 sexual abuse and 16 sexual harassment, were substantiated. All cases involving staff were received, assessed, and processed by GEO's Office of Professional Responsibility. When criminal activity was suspected, GEO referred the allegations of sexual abuse or sexual harassment to an agency with the legal authority to conduct criminal investigations.

Furthermore, of the 108 allegations involving staff and sexual abuse received in 2021, 14 were pat search allegations; all were investigated, and none were substantiated. The majority were determined unfounded, as the touching was incidental to staff performing official duties in accordance with established search policies or after reviewing facility video monitoring technology.

• GEO received 429 allegations in 2021. Allegations decreased from 447 in 2020 to 429 in 2021. This is a decrease of 18 allegations.

• U.S. Secure Services received 359 allegations in 2021. Allegations increased from 322 in 2020 to 359 in 2021. This is an increase of 37 allegations.

• Reentry Services received 45 allegations in 2021. Allegations decreased from 80 in 2020 to 45 in 2021. This is a decrease of 35 allegations.

• Youth Services received 25 allegations in 2021. Allegations decreased from 45 in 2020 to 25 in 2021. This is a decrease of 20 allegations.

Comparison of Substantiated Allegations

- There were 31 substantiated allegations GEO-wide in 2021. Substantiated allegations decreased from 47 in 2020 to 31 in 2021. This is a decrease of 16 substantiated allegations.
- There were 23 substantiated allegations for U.S. Secure Services in 2021. Substantiated allegations decreased from 30 in 2020 to 23 in 2021. This is a decrease of 7 substantiated allegations.
- There were 6 substantiated allegations for Reentry Services in 2021. Substantiated allegations decreased from 14 in 2020 to 6 in 2021. This is a decrease of 8 substantiated allegations.
- There were 2 substantiated allegations for Youth Services in 2021. Substantiated allegations decreased from 3 in 2020 to 2 in 2021. This is a decrease of 1 substantiated allegation.

- There were 168 IISA/RRSA allegations reported to GEO in 2021. IISA/RRSA allegations increased from 165 in 2020 by 3 to 168 in 2021. This is an increase of 3 IISA/RRSA allegations.
- There were 144 IISA allegations reported to U.S. Secure Services in 2021. IISA allegations increased from 126 in 2020 to 144 in 2021. This is an increase of 18 allegations.
- There were 11 IISA allegations reported to Reentry Services in 2021. IISA allegations decreased from 17 in 2020 to 11 in 2021. This is a decrease of 6 IISA allegations.
- There were 13 RRSA allegations reported to Youth Services in 2021. RRSA allegations decreased from 22 in 2020 to 13 in 2021. This is a decrease of 9 RRSA allegations.

- There were 69 IISH/RRSH allegations reported to GEO in 2021. IISH/RRSH allegations decreased from 81 in 2020 to 69 in 2021. This is a decrease of 12 IISH/RRSH allegations.
- There were 60 IISA allegations reported to U.S. Secure Services in 2021. IISH allegations decreased from 62 in 2020 to 60 in 2021. This is a decrease of 2 IISH allegations.

- There were 108 SISA/SRSA allegations reported to GEO in 2021. SISA/SRSA allegations decreased from 122 in 2020 by 14 to 108 in 2021. This is a decrease of 14 SISA/SRSA allegations.
- There were 81 SISA allegations reported to U.S. Secure Services in 2021. SISA allegations increased from 72 in 2020 to 81 in 2021. This is an increase of 9 SISA allegations.
- There were 18 SISA allegations reported to Reentry Services in 2021. SISA allegations decreased from 39 in 2020 to 18 in 2021. This is a decrease of 21 SISA allegations.

- There were 84 SISH/SRSH allegations reported to GEO in 2021. SISH/SRSH allegations increased from 79 in 2020 to 84 in 2021. This is an increase of 5 SISH/SRSH allegations.
- There were 74 SISH allegations reported to U.S. Secure Services in 2021. SISH allegations increased from 62 in 2020 to 74 in 2021. This is an increase of 12 SISH allegations.
- There were 8 SISH allegations reported to Reentry Services in 2021. SISH allegations decreased from 10 in 2020 to 8 in 2021. This is a decrease of 2 SISH allegations.
- There were 2 SRSH allegations reported to Youth Services in 2021. SRSH allegations decreased from 7 in 2020 to 2 in 2021. This is a decrease of 5 SRSH allegations.



2021 PROGRAM ENHANCEMENTS

Actions in 2021:

In 2021, GEO implemented the following actions to enhance the prevention and detection of any incidents and to enhance responses to allegations of sexual abuse and sexual harassment:

• Corporate Enhancements

- GEO's Contract Compliance Department (CC) streamlined its organizational layout by combining three director-level positions into one senior director position who serves as the national PREA Coordinator, American Correctional Association (ACA) Director, and Director of Project Management.
- CC added a fourth corporate PREA manager who reports directly to the GEO PREA Coordinator. Each corporate PREA manager serves as a single point of contact for his assigned facilities, reviews investigations, conducts remote and mock audits, facilitates certification audits, and provides guidance on PREA compliance.
- GEO's PREA portal was enhanced to improve the quality and standardize data captured in PREA surveys following an allegation.

• Training and education of employees, contractors and volunteers

- PREA database user training was provided to all new PREA compliance managers in U.S. Secure Services, Residential Reentry, and Youth Services.
- Employees, contractors, and volunteers received annual PREA in-service training as required by GEO policies in 2021.
- Forty-two employees from U.S. Secure Services, Residential Reentry, and Youth Services received PREA Specialized Investigations Training in 2021.

• Assessment of Physical Plant Issues at Facilities

 Annual PREA Facility Assessments were conducted in all GEO U.S. Secure Services, Residential Reentry, and Youth Service facilities to identify areas needing improvement to enhance the company's ability to protect inmates, detainees, and residents from sexual abuse and sexual harassment. All recommendations for enhancements were submitted and reviewed by the corporate PREA coordinator and appropriate divisional authority. For example, to reduce blind spots, 13 facilities recommended adding or updating camera surveillance monitoring systems, 6 facilities added additional video monitoring cameras, 1 facility added dome mirrors, 3 facilities posted opposite gender announcements inside and outside the dormitories, 2 facilities added privacy curtains to bathroom and shower areas, 1 facility constructed security doors to separate one housing unit into two separate housing units, 1 facility created pocket cards with important telephone numbers and facility codes for staff, 1 facility enhanced audio and video surveillance in transport vans, and 1 facility constructed and erected barriers between each dormitory toilet for privacy.
